Minutes of the meeting of the Medical Commission of FIDE on September 20th

1. Welcome remarks

3. History of doping control in FIDE

4. Update, Activities opportunities and challenges

Marape Marape gives an update of the doping controls in FIDE the last 12 months. There have been doping controls all over the world. There has been close to 200 testings. He has been testing at the Candidates Tournament in Toronto in Canada, the world rapid and

blitz, the Grand Swiss in the Isle of Man, in Chanti-Mansysk in Siberia, etcetera. In Budapest there have been 4 out of competition tests before the Olympiad and 10 tests in the Olympiad. More tests in the Olympiad will follow.

The FIDE is compliant with WADA.

5. Therapeutic Use Exemption

Daniel Scotland gives a presentation about the Therapeutic Use Exemption. A player who uses for medical reasons a medicine which is on the dopinglist, should ask in time for a Therapeutic Use Exemption.

6. Visual healthcare in chess objective

Amelia Hernandez (Venezuela), member of the Medical Commission gives an online presentation about Visual Healthcare in chess objective.

7. Diabetes and chess

Maria Rubio-Yuste gives a presentation about Diabetes and chess.

8. Applied neuroscience and chess

Professor Hersics gives a presentation about his study in Hungry in cooperation with scientists in Cuba of neuro technological means to improve the brains of the chessplayer.
